Training for ships subject to the IGF code - management level

According to the Ordinance on Vocations and Certificates of Competencies for Seafarers (of the Republic of Croatia):

(1) Ship master, engineer officers and other persons who are directly responsible for the care of fuels and fuel systems and their use on ships that are subject to the IGF Code shall hold the certificate of proficiency – operation on ships that are subject to the IGF Code – management level (STCW V/3).

(2) The certificate referred to in paragraph 1 of this Article shall be issued to the seafarer who:

- holds the certificate referred to in Article 67a of this Ordinance

- has completed special training specified in Annex D50B of this Ordinance

– has passed an examination to obtain such a certificate, according to the programme specified in Annex C51B of this Ordinance

- has a minimum of one month of seagoing service, which includes a minimum of three bunkering operations on board ships subject to the IGF Code, while two bunkering operations may be replaced by approved simulator training on bunkering operations as part of the training specified in Annex D50B (part: Plan and monitor safe bunkering, stowage and securing of the fuel on board ships subject to the IGF Code) or has participated in conducting three cargo operations on board the liquefied gas tankers, and".

- has a minimum of three months of seagoing service in the past five years on:

• ships that are subject to the IGF Code; or

• tankers transporting fuels that are subject to the IGF Code as their cargo; or

• ships that use gases or other low-flashpoint fuels as their fuel.

(3) Crew members who hold the certificate referred to in Article 66 of this Ordinance and who fulfil the conditions referred to in paragraph 2, subparagraphs 4 and 5 of this Article shall not be under obligation to fulfil the condition laid down in paragraph 2 of this Article with respect to special training and passing of examinations required for obtaining the relevant certificate.

(4) Participation in fuelling or fuel transshipment, as prescribed by paragraph 2 of this Article, is proven by a signed statement of the ship master, shipping company or intermediary.

(5) The certificate referred to in paragraph 1 of this Article shall be valid for 5 years since the date of issue."
